Subject Social Housing Grant programme

Purpose To confirm with the Cabinet Member for Adult and Community Services the Social Housing Grant Programme submitted to the Welsh Government in June 2015, for the period 2015-2019.

- **Summary** Sole responsibility for the Social Housing Grant Programme transferred to all local authorities in Wales on the 1st April 2011. An allocation of capital finance is conferred each year and the City Council then determines the housing schemes to be constructed by partner housing associations. A 3 year indicative capital allocation is provided. There is no requirement for match funding by Newport City Council, housing associations will provide the additional funds through private finance.

Proposal To agree the proposed Social Housing Grant Programme.

1. Background

- 1.1 Since 2011 local authorities have been provided with a capital allocation of Social Housing Grant.
- 1.2 A programme delivery plan (PDP) has to be submitted every quarter by the local authority to detail progress with the expenditure of this capital sum. The authority also has to authorise each payment to the housing association.
- 1.3 The PDP also includes an approved list of reserve scheme that can be included in the programme if further capital finance is made available. Approval is sought for this list so that the City Council can respond in a timely manner to requests for schemes if such finance comes forward.
- 1.4 The Social Housing Grant allocation provides the capital finance to deliver new affordable housing. The money constitutes 58% of the costs of building new homes, the remaining 42% is private finance raised by the housing associations as traditional mortgages.
- 1.5 The Welsh Government has provided an indication of the capital allowance (referred to as the Cash Limited Allocation) that Newport will receive for the next 3 years. The PDP then shows how this money will be spent within the City. The PDP is appended to this report.
- 1.6 In order for schemes to be delivered they have to have full planning consent, an agreement has been reached with the landowner or the housing association already owns the land, and the tender price for construction is cost effective.
- 1.7 The plan also details future schemes which could be delivered within the city this has 2 functions :
 - a) it provides alternative schemes for the authority to substitute if a scheme within the programme is unable to progress.
 - b) it provides evidence for colleagues within Welsh Government to demonstrate the need for additional funding. This additional funding often becomes available towards the end of the financial year and local authorities are expected to respond extremely quickly to the call for bringing schemes forward.
- 1.8 The Strategy & Development Manager manages the Social Housing Grant Programme on a daily basis, monitoring the delivery of affordable housing, submitting the appropriate forms to the Welsh Government and ensuring that all new opportunities for housing are fully explored.

2. Financial Summary

2.1 The financial resources required to manage the Social Housing Grant Programme are already included within the department's set budget for the financial year i.e. the Strategy and Development Manager, currently manages the whole process.

7.1 The Social Housing Grant programme is managed through existing staff members within the Strategy and Development service. There are no further revenue implications resulting from this proposal as no money passes through NCC. This is purely an administrative function being carried out within the team.

8.1 There are no legal issues arising from the Report. The matter has been referred to the Leader of the Council for an executive decision because the Cabinet Member has declared a personal interest. The Social Housing Grant Programme identifies an indicative allocation of capital funding for social housing schemes in Newport for the next 3 years, as required by Welsh Government, and the accompanying plan identifies progress with the delivery of each project within the programme.
